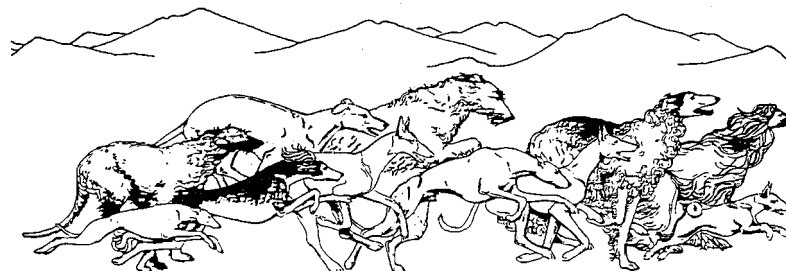

ROLL CALL AND INSPECTION

7:15 am, Hounds not present at roll call will be marked absent and are not eligible for refund of entry fee.

RACE INFORMATION

All breeds will be **hand slipped** at this race meet.

All hounds will run muzzled. CLCA does not provide muzzles.

A limited number of racing jackets in various sizes will be available from CLCA.

Only the following colors shall be used:

Red Jacket – White numeral"1" White Jacket – Black numeral"3"

Blue Jacket – White numeral"2" Green Jacket – White numeral "4"

ENTRY FEES

Pre-Entries: the entry fee for the first hound will be \$12 and \$10.00 for each additional hound with the same owner if received by the Race Secretary by **Thursday, June 18, 2009.**

Gate Entries: Entries will be accepted the morning of the meet, up until 7:00 am, at a gate entry fee of \$20.00 per hound.

AWARDS Ribbons will be awarded for 1st through 5th place. Trophies will be awarded for 1st place.

ELIGIBLE HOUNDS

Hounds must be one year of age or older to be entered. All hounds must be registered with LGRA.

Only purebred Afghan Hounds, Azawakh (*provisional*), Basenji, Borzoi, Chart Polskis, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Magyar Agar (*provisional*), Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds and Sloughi may be entered in an Official Race Meet.

WHAT IS LGRA?

LGRA is sprint racing for GazeHounds. The hounds run 200 yards straight after a lure consisting of a fur bag and squawker. Up to four hounds race a total of three times, called programs. Depending on the order of finish, they may attain national points towards a GRC, GazeHound Race Championship title.

No Pre-certification of your hound is required, although a schooling run may be required.

GENERAL INFORMATION

Race Site: The grounds being used for this race are not completely flat.

*** Dry Camping will be available free of charge.**

* BRING WATER AND SHADE FOR YOUR HOUNDS.

* Porta-potties on site.

* A \$5.00 fine will be assessed to the owner or handler of any hound loose on the field but not competing in the race in progress.

*** If you dog is not registered with LGRA you must provide a copy of your dog's AKC registration (or foreign registration) and a one time \$2.00 registration fee.**

REGISTRATION WITH LGRA

All hounds must be registered with LGRA. The hounds must be individually registered with a recognized registry for purebred GazeHounds in order to register with LGRA.

The following registrations are approved by LGRA: American Kennel Club (AKC), Canadian Kennel Club (CKC), United Kennel Club (UKC), National Greyhound Association (NGA), or any recognized foreign registry for purebred progeny of GazeHound breed. Hounds registered with the AKC under Indefinite listing Privilege (ILP) or the CKC equivalent may also be registered.

**DIRECTIONS TO THE CLCA LGRA SITE
(ZOIBOYZ RANCH, 2115 CURTIS ROAD, PEYTON CO)**

FROM THE NORTH

1. From I-25 South, take exit 153 Interqwest Parkway/Hwy 83
2. Go on Hwy 83 to South Powers Blvd
3. Turn right on South Powers Blvd
4. Stay on Powers to Woodmen Road
5. Go left (east) ~12 miles on Woodmen to its end at Hwy 24
6. Go right on Hwy 24 0.5 miles to Meridian
7. Go left on Meridian to STOP sign at Falcon Hwy
8. Turn left onto Falcon Hwy ~3 miles to flashing yellow (Curtis Rd)
9. Turn right (south) onto Curtis Road for 4.4 miles
10. Turn left to Zoiboyz Ranch (NOTE: This will be the 2nd driveway on left after Davis Road. Ignore small house near Curtis; go up the hill to the house surrounded by white fence. You've gone too far down Curtis if you come to Hwy 94 and a traffic signal).

FROM THE SOUTH

1. From I-25 North, take exit 135 Academy Blvd
2. North on Academy 5.8 miles to East Platte Ave
3. Right on E. Platte 3.7 miles to Hwy 94 (direction Shriever AFB)
4. Right on Hwy 94 7.5 miles to Curtis Road (1st light on Hwy 94)
5. Left on Curtis Road 1.9 miles to Zoiboyz Ranch on right—house surrounded by white fence on hill. (Ignore the small house in front near Curtis Road. You've gone too far north on Curtis if you come to Falcon Hwy and blinking red traffic signal.)

FROM THE EAST

1. From I-70, take exit 359 (US Hwy 24) 54 miles to Falcon Hwy
2. Left (east) on Falcon Hwy 3.3 miles to Curtis Road
3. Right (south) on Curtis Road 4.4 miles to Zoiboyz Ranch. (NOTE: This will be the 2nd driveway on left after Davis Road. Ignore small house near Curtis Rd, go up the hill to the house surrounded by white fence. You've gone too far down Curtis if you come to Hwy 94 and a traffic signal).
